MYTHs for E-invoicing

- Does it mean Invoice to be prepared on Government Portal with their format ?? – BIG NO
- E-invoice as a system where taxpayers can generate the invoices Centrally – NO
- It's a NEW / standard Invoice format being designed now – NO!
- Invoices generated by each software would look same – NEVER!
- It is only for Invoice and NOT for Credit / Debit Notes – NO!
- 'e-invoice' is about invoice being in soft copy like PDF etc. – NO!

What is E-Invoice?

- E-Invoice = Tax Invoice [Rule 46] + IRN + QR Code [embedded IRN]
- As per Rule 48(4) of CGST Rules,
 - notified class of registered persons
 - to prepare invoice
 - by uploading specified particulars in FORM GSTINV-01
 - on Invoice Registration Portal (IRP) and
 - obtain Invoice Reference Number (IRN)
- After following above 'e-invoicing' process, the invoice copy (with QR Code containing inter alia, IRN) issued by the notified supplier to buyer is commonly referred to as 'e-invoice'.

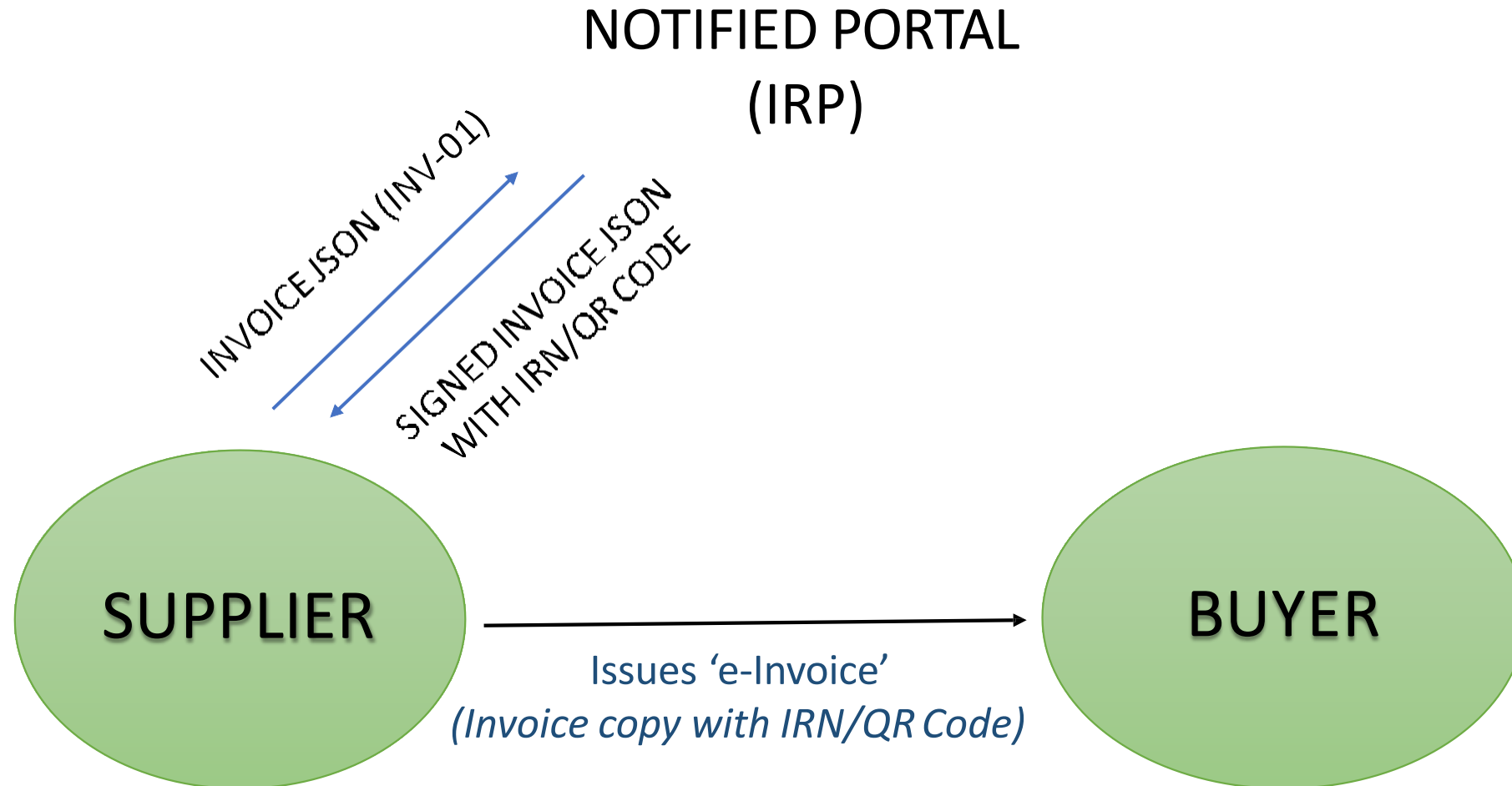

"E-Invoice", "QR Code" and "Dynamic QR Code" Applicability – From 01-08-2023

- Also, if ATTO exceeded 5 Cr. and E-invoice is not Applicable as above, A Declaration **ON EACH TAX INVOICE** is needed, as below:

"I/We hereby declare that though our aggregate turnover in any preceding financial year from 2017-18 onwards is more than the aggregate turnover notified under sub-rule (4) of rule 48, we are not required to prepare an invoice in terms of the provisions of the said sub-rule"

A Person having Turnover above 5 crore supplying Goods / Services Falling under Reverse Charge, Does he needs to Prepare E-Invoice?

Workflow

- Login with E-waybill Credentials OR Register
- Tax payer will continue to create their GST invoices on their own Accounting/Billing/ERP Systems
- Tax Payer to generate the invoice from ERP / Accounting system [API Based] /GePP Tool/ Gepp-On Tool/ Json Preparation Tool containing all mandatory fields as provided in e-invoice schema
- Seller may upload the JSON either
 - directly on IRP or
 - through GSP or ASPs [Tally, Zoho, ClearTax etc]
 - through third party provided Apps
 - through online filling the data on Gepp-On Tool
- IRP would generate the IRN. It would also digitally sign the invoice and generate QR code which will contain all the key information of the invoice
- DOWNLOAD The signed Json, PDF and excel as the same detail won't be retrievable after 2 days from the IRP
- Eway Bill on E-Invoice Portal

'E-way bill' V/S 'E-Invoicing'

Precautions for all the Recipients [With Any Turnover]

- One time exercise to checking the enablement of the E-invoicing to all the Suppliers on 01-04-2023 on E-Invoice Portal [No Login Required]
- Once list of enabled supplier classified, Check Rigorously IRN Number, QR Code on each of the purchase Invoice
- In case of any doubt for any Tax Invoice having IRN / QR Code, Scan the QR Code on mobile App OR Demand the Signed Json from the supplier and validate on E-Invoice Portal

Transmission of E-invoicing data to GSTR-1

- T+2 Days
- Having Source – E-Invoice
- If edited, Source will get removed. If GSTR-1 uploaded again via Json, Source will get removed
- Auto-populated in the “Period of GSTR-1” based on “Document Date” of E-invoice [And not Actual date of uploading on IRP]
- If Reported to IRP after filling GSTR-1, it won't Auto-populate at all.
- Same Document Number already filled in GSTR-1 before T+2 days, it won't be replaced by IRP
- Vlookup
- GSTN enabled the functionality to find the Invoice Reference Number (IRN) through the Document Number

Invoice Reference Number (IRN)

- IRN is a unique 64-character hash/string Eg.
“35054cc24d97033afc24f49ec4444dbab81f542c555f9d30359dc75794 e06bbe”
- A GST invoice will be valid only with a valid IRN
- IRN Need not be printed on e-invoice (It’s already embedded in QR Code)
- An invoice/document number which was reported and obtained IRN, can’t be used again

Invoice Reference Number (IRN)

- REPORTING: No prescribed time window for reporting to IRP [REALTIME REPORTING] – **CAUTION**
[NN 73-2020 CT 01-10-2020 – Only waiver]
- CANCELLATION:
 - i. IRN can be cancelled within 24 hours (from the time of generation of IRN)
 - ii. However, if the connected e-way bill is active or verified by officer during transit, cancellation of IRN will not be permitted.
 - iii. In case of cancellation of IRN, GSTR-1 also will be updated with such 'cancelled' status in excel report.
 - iv. Once Cancelled, the same Invoice Number can not be used again to generate IRN
- AMENDMENTS:
 - i. Amendments are not possible on IRP.
 - ii. Any changes in the invoice details reported to IRP can be carried out on GST portal (while filing GSTR-1).

QR Code

- Along with signed invoice, IRP will also give a QR code containing the unique IRN and below key particulars:
 - i. GSTIN of supplier
 - ii. GSTIN of Recipient
 - iii. Invoice number as given by Supplier
 - iv. Date of generation of invoice
 - v. Invoice value (taxable value and gross tax)
 - vi. Number of line items.
 - vii. HSN Code of main item (the line item having highest taxable value)
 - viii. Invoice Reference Number (IRN)
 - ix. Date of generation of IRN

Dynamic QR Code

- Content of Dynamic QR Code:
 - i. Supplier GSTIN number
 - ii. Supplier UPI ID
 - iii. Payee's Bank A/C number and IFSC [Not Req if UPI ID linked with Bank A/c]
 - iv. Invoice number & invoice date
 - v. Total Invoice Value
 - vi. GST amount along with breakup i.e. CGST, SGST, IGST, CESS, etc
 - vii. payment reference link
- Dynamic QR Code should be such that it can be scanned to make a digital payment
- Display of Dynamic QR Code in DIGITAL DISPLAY & Cross Reference of such payment mentioned **on Invoice [Before Printing of such Invoice]** – Deemed to be complied
- Supply to UIN Holder, Dynamic QR Code Required
- Incase of supply via Ecommerce Operator, Dynamic QR Code also to be issued by the supplier
- However, UPI ID in such Dynamic QR Code may be given on E-com Operator

GST Special Drive – Dos and Don'ts

Basic Things One Must Consider...

- GSTIN on Name Plate - **on Every Business Premise** (visible even if shutter is closed)
- GST Certificate on wall after entering the premise - **on Every Business Premise**
- Every Office, Godown, Mines, Business Premise to be added in GST Certificate
- Mobile and Email – Auto Forward
- Basic Documents which were submitted in registration, such as Rent agreement, Sale deed / Index II, Electricity bill, Proof of constitution of business, Bank Details.
- Documents (Sale/Purchase register, Stock Register and others as per Accounts and Records Rule) to be kept at registered Premise
- all changes has been updated with GST department including changes in Director or Partner details

What is GST Special Drive?

- No Change in law for the period 16-05-2023 to 15-07-2023
- Identification of Fraudulent GSTINs from Data Analytics and Risk parameters (From DGRAM / BIFA / ADVAIT / NIC Prime)
- Only allowed after issuance of INS-01 by JC
- **Without INS01 visit by any Officer is 'illegal'**
- *Suspicion must be proved*

During the Inspection in INS-01

- Officer can collect Specific invoices (and all invoices) and e-way bills
- Officer can collect Supplier ledger account with payment details.
- No 'spot' recovery
- No power to seize stock or assets
- Power to issue summons allowed
- Investigation cannot be expanded to (i) GSTR2A v. 3B (ii) GSTR1 v. 3B (iii) rule 42-43 reversals (iv) section 17(5) blocked credits or (v) other routine matters not related to fake invoice.

Possible Adverse Outcome, If Officer not satisfied

What Possibly Can be Done	Suspend or cancel registration (section 29)	Block credit (rule 86A) without giving any notice or hearing *by Commissioner	Issue notice (section 74)	Provisional Attachment (Sec 83)
Steps by taxpayer	Apply for revocation of cancellation (Form REG21) within thirty (30) days	File letter of objections and demand written reply for blocking credit	Accept and pay or dispute and litigate demand *	File letter of objections
Business of taxpayer	Comes to stop on cancellation of registration	Continues even if some credits are blocked	Continues (until adjudication and final disposal in appeal)	Debit side of Bank account will be freezed
